

RELEASE AND WAIVER OF LIABILITY

WHEREAS; LTP Tennis, LLC, its Landlord, and agents (collectively "LTP") is conducting a summer camp each for registered children ("LTP Camp");

AND WHEREAS: I desire to have my child, name and further described above, participate in the LTP Camp;

AND WHEREAS; I acknowledge that I agree that I will abide by and take responsibility for my child following the rules and regulations of the LTP Camp as they are announced or distributed;

NOW therefore, for and in consideration of my child's being allowed to participate in the LTP Camp, I, on behalf of my child, our family members, my estate, my child's estate, our administrators, executors, agents, heirs, agents, and assigns, do hereby consent as follows:

- I acknowledge that my Child's participating in the LTP Camp is solely on my own initiative, risk and responsibility;
- I understand that LTP Camp does not provide any transportation to or from the LTP Camp and that I am solely responsible for ensuring that my child makes it to and from the activities in a safe manner;
- I accept and appreciate that there are certain risks and dangers involved in the activities my child will participate in at the LTP Camp, including but not limited to the hazards of traveling, hiking, sports injuries, swimming, boating, accidents or illness in remote places without immediate medical facilities, including forces of nature.
- I give permission and authority for LTP staff to provide any medical assistance they feel appropriate for my child named above, however, I specifically understand and acknowledge that my giving of such permission and authority does not create any obligation on LTP or the LTP Camp to make any decisions, contact any persons, or otherwise perform any actions with respect to my child.

- I also give permission for any licensed hospital, treatment facility, doctor or emergency personnel in the state of South Carolina to treat my child in the event of an emergency. I will be responsible for any and all medical expenses that may be incurred.
- I acknowledge and understand that the LTP Tennis does not provide medical insurance, life insurance, or any other type of insurance which might provide medical coverage or benefits to me. I understand and agree to pay for the costs of any personal coverage.
- I voluntarily release, discharge, waive, relinquish, indemnify and forever hold harmless and covenant not to sue LTP and LTP Camp, and any of their respective officers, trustees, agents, assigns, and employees, from any and all lawsuits, actions or causes of actions, claims in law or equity, demands, liabilities, costs, expenses, property damage, personal injury, or death, including attorney's fees, which result from or may arise out of participation in connection or in connection with the LTP Summer Camp, occurring inside, on, outside, or off of the LTP Tennis Property. I HAVE CAREFULLY READ AND VOLUNTARILY CONSENT TO THIS RELEASE AND WAIVER.

I UNDERSTAND IT TO BE A RELEASE OF ALL CLAIMS AND CAUSES OF ACTION FOR MY CHILD'S INJURY OR DEATH OR PROPERTY DAMAGE THAT OCCURS WHILE PARTICIPATING IN THE LTP SUMMER CAMP.

This signed agreement shall serve as a release or assumption of risks for my heirs, executor and administrators, next of kin and for members of my family.

Any photos or videos of my child taken by LTP or LTP Camp will remain the property of Live to Play to be used in promotion.
